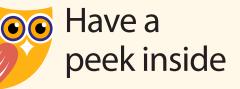


McCarthy's Corner

SAO transitioned to new file sharing tool on Sept. 1

Earlier this summer we announced SAO would be phasing in a new data-sharing tool for audits. Starting Sept. 1, SAO's SecureShare is our primary tool for exchanging audit information with state and local governments.

SAO developed the tool after consultation with Washington Technology Solutions (WaTech), the state's IT agency. Our programmers and technicians then worked with Microsoft to develop this customized application built on trusted, reliable technology. We have emailed clients with invitations to join their dedicated share space.

Once you receive your invitation, please activate your account as soon as possible. We will notify you when you need to use your account to share audit data with us.

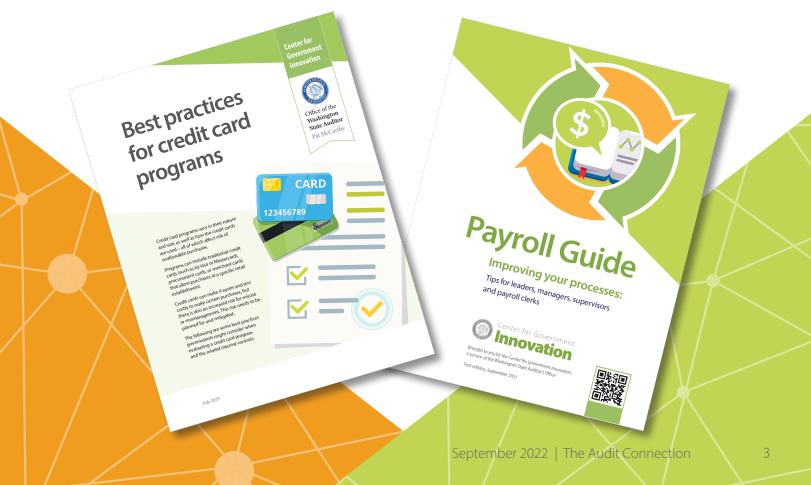

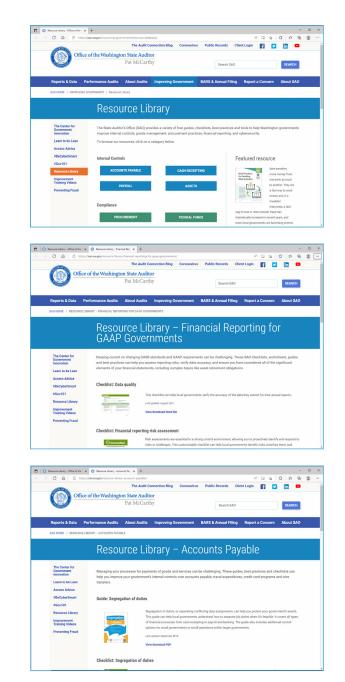
Top 5 things you can do on SAO's new resource library:

Reporting a known or suspected loss to SAO? Be ready for a few new questions

When your government becomes aware of a known or suspected loss of public funds, state law requires that you immediately report it to the State Auditor's Office. The most effective way to report is through the "**How to Report a Concern**" page on SAO's website. If you've reported a loss in the past and are coming back to report something new, you may notice some new questions on the reporting form, including:

- What is the time period of the suspected loss? In other words, when do you suspect the loss started and ended?
- Describe the estimated dollar amount lost. In other words, how you did determine the amount, and what does it include?
- If you suspect employee involvement, what is the name and title of the person who may have been involved? What are their major job responsibilities, and what areas or functions do they have access to? Is that person still employed by your agency?
- Who at the agency is aware this concern is being reported?
- If you're reporting a cyber-related loss, what kind is it (e.g., ransomware)?

Why the new questions?

The information you provide in your report helps us more effectively triage the case and determine next steps, which could be anything from launching an investigation to closing the case without any further action.

When we don't have enough information, we'll often ask your audit team to contact you with additional questions. The audit team then will consult with our Special Investigations Team whose work will be billed to you if we open an investigation.

In an effort to triage more cases without involving the Special Investigations Team, we looked at past cases. We considered what information we would have needed in the initial loss report to triage without involving the audit team. Our analysis led to the new questions in the loss reporting form.

What if I can't answer all the questions when I submit a loss report?

Don't worry! We understand that you might not have all the information yet, but you should still report losses as soon as you suspect them. Just fill out what you can. If you want to update a loss report, let us know at Fraud@sao. wa.gov — please don't send us sensitive or confidential information through email.

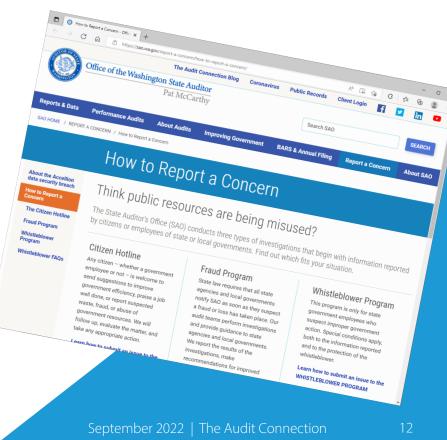

Performance audits that may inform local government practices

I-1163: Testing and Certification Barriers for Home Care Aides (published 9/8/2022)

Initiative 1163 requires many long-term care workers pass both knowledge and skills tests to become certified to provide in-home care to elderly and disabled people. The Department of Health oversees certification, and contracts with a private testing company to organize and administer the test at sites across Washington. This performance audit found the number of regional test sites dropped 20 percent since our 2016 audit, leaving workers in cities including Vancouver, Aberdeen and Pullman more than an hour away from the nearest location. We made a series of recommendations to the department to address delays between training and testing, the lack of test sites, and gaps in performance and contract management.

Contracted Homelessness Services: Improving how local governments prioritize contracts and manage provider performance (publishing fall 2022)

Washington has a growing population of people without homes, especially in its highly populated urban areas. Many local governments have devoted significant resources to addressing the homelessness problem, including contracting for services through not-for-profit agencies. Stakeholders have raised concerns about some of those contracts, noting that contracts lacked required performance targets and demonstrated results. This performance audit examines the processes selected cities and counties used to identify and prioritize the homeless services they need. It also looks at how they monitor and manage performance of providers they contract with for services. The audit seeks to identify recommendations that would help local governments contract for more effective services.



New audits to offer transparency into use of deadly force investigations; clean energy purchases

Use of deadly force investigations

As a result of the 2021 Legislative Session and E2SHB 1089, our Office will complete a process-compliance audit and a review of investigations into law enforcement's use of deadly force that happened after January 6, 2020. We are the first public auditors in the United States to conduct this type of examination. Our final reports will explain what we found, elaborate on causes of noncompliance, and may provide recommendations to the law enforcement agency, the prosecuting attorney and others.

Clean Energy Transformation Act

The Clean Energy Transformation Act (CETA) went into effect in 2019, creating new requirements on electric utilities to transition over time to clean energy resources to supply their retail customers. It also prescribes penalties for noncompliance with some requirements.

CETA requires the Office of the State Auditor to audit consumer-owned utilities' compliance with the law. SAO has several of these new audits in progress, and those reports will be issued this fall.

Who is subject to these new audits?

CETA applies to all electric utilities that are in the business of distributing electricity to more than one retail customer in the state of Washington, including consumer-owned (public) electric utilities.

When will SAO perform the compliance examinations?

The following summarizes a possible upcoming schedule of the compliance periods and related requirements.

Examinations occurring in 2022-2023 of the compliance period Jan. 1, 2019 – Dec. 31, 2021

- Greenhouse gas content calculation (RCW 19.405.070)
- Energy assistance for low-income households (RCW 19.405.120)
- Clean energy implementation plan (RCW 19.405.060)

Examinations occurring 2023 – 2024 of the compliance period Jan. 1, 2022 – Dec. 31, 2023

- Greenhouse gas content calculation (RCW 19.405.070)
- Energy assistance for low-income households (RCW 19.405.120)

Audit billing rate for 2023

For planning and budgeting purposes, we recently notified our clients that SAO's hourly billing rates as of Jan. 1, 2023 will be as follows:

Local Government Audits	\$128
Fraud Investigations	\$210
Energy Independence Act/Clean Energy Transformation Act Audits	\$165

The hourly rate for auditors in travel status will remain at 75 percent of the applicable hourly rate.

SAO evaluates the billing rate each summer, planning for the coming calendar year and accounting for legislative changes and other factors. The rate adjustment for 2023 is related to increased costs of both salaries and benefits. This includes legislatively-approved cost-of-living increases for all state employees beginning July 1, and salary

increases for our auditors, one of several classification increases initiated by the state Office of Financial Management specifically intended to improve recruitment and retention.
