Dear SAO Public Records Officer,

I am following up on my public records request submitted to State Auditor's Office on July 29th, as well as my follow-up email sent on August 7th (both attached).

As of today, I have not received any acknowledgment or response. Under RCW 42.56.520, agencies are required to respond within five business days by:

- Providing the requested records,
- Providing a reasonable estimate of the time required to respond,
- Requesting clarification, or
- Denying the request with a valid exemption.

Because SAO has failed to respond within the statutory timeframe, this constitutes a failure to comply with the Public Records Act.

Please confirm receipt of this email and provide an acknowledgment and estimated timeframe for fulfillment within three business days, August 20th. If I do not receive a response, I will escalate this matter to the Attorney General's Open Government Ombuds and consider further remedies under RCW 42.56.550(4).

Pursuant to the Washington Public Records Act (RCW 42.56), I am requesting the following records:

1.

A list of all law enforcement agency audits conducted by the State Auditor since January 1, 2023 that reviewed compliance with RCW 43.101.135 or any other reporting requirements to the Criminal Justice Training Commission (CJTC) regarding officer separation, discipline, or misconduct.

2.

Copies of all final audit reports produced as part of these reviews (or direct links to reports if publicly posted).

3.

Any available summary or spreadsheet that identifies which agencies have been audited for CJTC reporting compliance and the date each audit report was published.

4.

If available, any SAO “planned audit list” or internal tracking document showing which agencies are scheduled for CJTC compliance audits through 2026.

This request includes any records, reports, or lists maintained by the SAO that identify which agencies have been audited for CJTC compliance and when those audits were completed.

I am requesting electronic copies of these records. If any portion of my request is unclear, please contact me to clarify or narrow the scope as needed.

Thank you for your assistance, and I look forward to your response within five business days as required under RCW 42.56.
