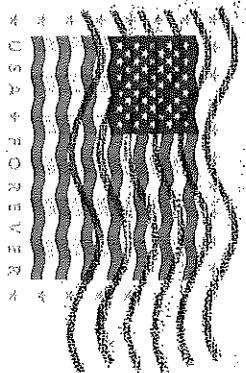

Dear Public Records Officer,

This is a request of the disclosure of public records pursuant to Chapter 42.56 RCW, et seq., Washington's Public Records Act (PRA). One is requesting that you disclose and produce all documentation in the nature of the assigned name and identifying number(s) as shown below, pertaining to the period of June 1, 1997 through the present. This request seeks to substantiate claims of Rights violations allegedly occurring in Superior Courts of King and Skagit counties, Washington State. This request seeks records related to revenue-raising schemes resulting in the violation of commercial and securities Law.

The records I seek to inspect, copy, and receive are as follows :

1.) The Bonding information, registration statement and name of transfer agent (CUSIP number & assessment, omid,omad, 1099ID, 1099INT for any and all "CHARGES") in regards to : Joseph Dale Kennedy and originating case numbers : 97-1-05445-8, 99-1-01359-6, 00-1-03618-0, 02-1-00511-9, Washington State Court of Appeals Div. I case number 79750-6-I, Washington State Supreme Court case number 97699-6, Agency numbers WA 017015J, WA 029015J and credit item number 43-1112814.

2.) The authentication of authority (oaths of office and bonding information) of credit item signatory KENNEDY, JOSEPH D., of corporation agents Thomas L. Verge, WSBA #17944.

3.) The following generated commercial instruments :

- A.) GSA form SF24 "Bid Bond"
- B.) GSA form SF25 "Performance Bond"
- C.) GSA form SF25A "Payment Bond", under the "Comptroller of the Currency" under the "General Accountin Office" (GAO).

4.) The signed, Certified Verification of assessment, the name of the registered public accounting firm and name of auditor who assessed the "CHARGE", credentials, oath, Name and contact information.

5.) Produce any record of "proof" that any section(s) of the Washington State Securities Act RCW 21.20 the Credit item signatory KENNEDY, JOSEPH D., authorizes a city/state attorney the eligibility to engage in securing a "Bond" in a name in resemblance to One's ordinate appellation Joseph D. Kennedy without One's knowledge or authorization.


6.) Produce any record of "proof" that any section(s) of the Washington State Securities Act RCW 21.20 authorizes a city/state attorney to act as an Investment advisor representative, withholding the information pertaining to the name of "holder and bonding agent/transfer agent", as well as the value and accounting of said bond as described in [RCW 21.20.005 Definitions] .

7.) Produce the State 28-E agreements (between the State and Federal governments) to secure grants from the Feds and to insure compliance with Federal Law and produce any record of "proof" exactly where and how am I, Joseph D. Kennedy is party to these agreements.

Please remember that if any of these records contain exempt information, you may redact only the exempt information and must produce the remainder of the document. If you redact information or withhold any record, please discharge the duty imposed upon you by the Public Records Act to provide a privilege log identifying the information or records withheld, the statute authorizing the withholding, and providing a brief explanation of how that statute applies to exempt the information or record.
